ORDER:

In the G.O $1^{\rm st}$ read above, Government have approved a scheme for providing training in trades and vocations not limited to construction activity to the spouse and adolescent children of registered building and other Construction workers.

- 2. In the resolution 2nd read above, A.P. Building Other Construction Workers Welfare Board in its 15th meeting held on 28.11.2015 have passed resolution formulating a scheme to conduct the placement linked residential training Programme to 15,000 dependents of Construction Workers through APMES Society under Employment & Training Department of A.P. Government during 2015-2016 and also resolved to pay training course fee of Rs.30/- per hour per candidate and also Boarding & Lodging cost of Rs.300/- per candidate / per day and 4% administrative cost.
- 3. In the letter 3rd read above, the Commissioner of Employment & Training has informed that consequent on the orders issued in the reference 1st read above, the A.P. Building Other Construction Workers Welfare Board in their resolution has decided to take-up residential training to 15,000 dependents of the construction workers through Employment & Training Department with a Budget of Rs.25.67 Crores and further reported that the Director General of Employment & Training, New Delhi has permitted vide Letter.No.DGET-7/1/2015-MES/IS,dated:20.11.2015 to take-up the training programme for the dependents of the construction workers through MES Society by registered vocational Training Providers as per the guidelines in force.
- 4. The Commissioner of Employment & Training has further reported that the guidelines of the training programme have been approved by the Board for conduct of 70% placement linked residential training to dependents of Construction Workers. Accordingly, the guidelines are communicated to all VTPs for identification of dependents in a time bound schedule. Further, a Joint Committee was Constituted at District level with DCL/DEO and Principal of Government ITI as convenor for inspection of accommodation identified by the respective VTPs for both classroom and residential purpose and ACL will conduct a thorough verification on the status of dependent declared by the construction workers. On recommendation of the Joint committee, the batches are to be allotted to the VTPs and training accordingly gets commenced. Training cost and boarding charges to VTPs are to be released strictly as per the guidelines of MES programme. However, for tracking placement, release of payment of 20% funds to VTPs is to be withheld for a period of 6 months.

- 5. The Commissioner of Employment & Training has, therefore, requested the Government to permit to conduct the residential training programme for 15,000 dependents of the construction workers through the APMES Society out of Budget of Rs.25.67 Crores approved by Andhra Pradesh Building and Other Construction Workers Welfare Board. There is no financial burden on the State financial ex-chequer.
- 6. Government after careful Examination of the orders issued in the G.O. 1st read above, and resolution passed by APBOCWW Board in the reference 2nd read above, and the circumstances reported by the Commissioner of Employment and Training in the letter 3rd read above hereby permit the Commissioner of Employment and Training, Andhra Pradesh, Hyderabad to conduct the residential training programme for 15,000 dependents of the registered Building and Other Construction workers through APMES Society meeting the expenditure from out of the budget of Rs.25.67 crores provided by the APBOCWW Board. The Commissioner shall ensure that the guidelines of the MES Scheme of Government of India are followed strictly without any deviation. Further, the Commissioner shall also ensure that the ACL concerned should verify and confirm the declaration made by the worker in respect of dependents.
- 7. The Commissioner of Employment and Training, Andhra Pradesh, Hyderabad shall take further necessary action accordingly.
