ORDER:

In the G.O 1st read above, the Government have issued orders for implementation of welfare schemes by A.P. Building & Other Construction Workers Welfare Board workers to provide training to the Building & Other Construction workers in acquiring new skills/up-gradation of existing skills , safety and hygiene and also issued certain guidelines that Board shall extend toolkits and stipend to the workers who have successfully for completed the training programme.

2. In the reference 2nd read above, A.P. Building & Other Construction Workers Welfare Board in its 15th Board meeting held on 28.11.2015 have resolved to provide ToolKits to the Construction workers who are imparted with the Skill Upgradation Training in the trades of Masonry, Electrical & Plumbing and also resolved that One Lakh Tool Kits shall be acquired through e-tender process.

3. In the letter 3rd read above, the Commissioner of Employment & Training has informed that consequent on the orders issued in the G.O 1st read above, the A.P. Building Other Construction Workers Welfare Board in their resolution meeting held on 28.11.2015 has decided for procurement of 1 lakh toolkits @ Rs.2,000/- to each worker, who undergone skills training organized by the Board. Subsequently, the Board has authorized the Commissioner of Employment and Training to constitute technical committee and to provide a technical report on standard toolkit with specifications & approximate rates. Accordingly, the technical report was submitted with a committee of Government ITI Principals duly indicating the specifications and approximate rates covering the trades of Masonry, Electrical and Plumber. Further, keeping in view of the technical experience and expertise of supply of equipment & machinery in Government ITIs, the Commissioner of Employment and Training is authorized for procurement of toolkits vide Approval of the Chairman in file No.D/5247/2015, dt:24.02.2016 and Letter No.D/5247/2015 dt:25.02.2016.

4. The Commissioner of Employment and Training, AP, Hyderabad has, therefore, requested the Government to permit the Commissioner of Employment & Training to procure standard toolkits for supply to their trained workers by e-procurement process with a budget provided by the A.P. Building & Other Construction Workers Welfare Board. This has got no financial bearing on the Government Exchequer.
