ORDER:

In the G.O. 1st read above, the Government have approved the scheme for providing relief Rs.1,500/- per month for Temporary Disability (due to accident / disease) to the Building & other Construction workers to the registered building workers.

2. In the letter 2nd read above the Commissioner of Labour, A.P., Hyderabad, has submitted a proposal for enhancement of the existing amount Rs. 1,500/- per month to Rs.3,000/- per month towards relief for temporary disabilities (Hospitalization) to the registered building & other construction workers.

3. In the circumstances reported by the Commissioner of Labour, A.P., Hyderabad and after careful examination of the proposal, the Government hereby order enhancing the amount from the existing Rs.1500/- to Rs.3000/- for providing financial assistance to the registered Building & Other Construction workers towards relief for temporary disabilities (Hospitalization) under Rule 33 (L) of A.P. Building & Other Construction Workers Welfare Rules, 1999, read with Sec.22 of the Building & Other Construction Workers (RE&CS) Act, 1996, with the guidelines as prescribed in the G.O 1st read above .

4. The Commissioner of Labour, A.P., Hyderabad and the Secretary & CEO of the A.P. Building and Other Construction Workers Welfare Board shall take necessary action.
